Item 5:

Water System Report

 Cherokee County Fire Department is planning to install a fire hydrant on Hwy. 140. They requested that Lamar perform a fire test. Two tests were conducted, and the pressure ratings were 581 – 733. Lamar believes there is a valve issue between S. Land Rd. and Hwy. 140. It was discussed that we put in a PRV at Sardis Rd. We would need a bid on that before we proceed. A motion was put forth to locate the faulty valve by Councilman Blackwell and seconded by Councilman Cochran. This needs to be done before the city goes back to Cherokee County Fire. This project can be paid out of SPLOST funds.

- Lamar stated he is in communication with GEFA as to receiving funds to replace water lines. He will keep us updated on the status of when we will receive funds and the amount.
- Chris Lumpkin discussed the low chlorine levels on Sam Nelson Road and Hwy. 108. He stated he must flush the lines every other day, if not daily to keep at a level of .2. Some days it takes 15 minutes, and there have been times it can take an hour. This is causing the loss of many gallons of water. Chris suggested using an automatic flusher and Lamar suggested an automatic chlorinator device. Lamar will check on the cost for both options and update the council at our next meeting.

Item 6: City Manager Report

- Kim Kirsch notified the council that a gentleman came in last Friday asking about property for sale at the corner of Hwy. 108 and Reinhart College Pkwy. He was given the name and number of the property owner. He is looking for 8 acres to build a grocery store.
- Kim Kirsch notified the council that she spoke with Omega with Butter and Milk about their lease with ABF Horizon LLC in relation to their alcohol license. We have the paperwork in place currently for them to receive their alcohol license. A motion was made by Councilman Cochran and seconded by Councilman Brown and approved by all members present.

Item 7: City Attorney's Report

- Water System Matters John Meier discussed the Fate Conn Property.
 Plans for this project after confirmation that the pump acquired by
 Townsend will not work. Status of title to this property is unknown
 and we are waiting to obtain confirmation of location. John
 recommends the understanding be memorialized and acknowledged
 by CCWSA.
- Highpoint Subdivision no update
- Canyon Ridge Issues with the water pressure and other matters.
 Recommended discussing plans with Canton for the water tower originally planned for the development.
- 830 Puckett Creek Drive Information has been provided to Flint, Connolly & Walker attorneys. Meeting dates with FCW and the Mayor, City Clerk, and Councilmembers are to be set to discuss the encroachment into Waleska's Water and Sewer Service Area (WSSA)

- and establishing procedures for joint utility services and sanctions and violations.
- Fincher Road Water Line Easements Letter to be prepared to property owner requesting execution of easement agreement.
