 Mayor Lamb asked for a motion to approve round about, a motion was made by Councilmember Lee Lamb to not sign the letter of support at this time until questions were answered and brought back next meeting, seconded by Councilmember Bosch, Councilmember Boswell abstained due to her property being involved in the roundabout, 5 members approved 1 abstained.

Item 9: Discussion of SPLOST 2024

City Manager reported that there was a meeting with the County, Mayors and City Managers about SPLOST 2024. City Manager will need recommendations for projects for SPLOST 2024 by May 4, 2022.

Item 10: City Attorney's Report

- Attorney John Meier asked about the agreement with GA Power about Christmas lights, City Manager reported that this will be on the next agenda.
- Attorney John Meier reported he spoke with Kevin Turner and the city still had plenty of time to get all the zoning done for the Package Sale of Distilled Spirits
- Attorney John Meier reported on the code violations still out on 6171
 Reinhardt College Pkwy, that the code enforcement went to the wrong

- house, so the case was dismissed. City Manager reported that she will call and make another case on this address.
- Attorney John Meier spoke with Officer King about 7045 Reinhardt College Pkwy, a new citation was issued due to the condition of the roof. An arraignment is set for May 3rd, 2022, city manager will find out time. At this time, the owner will be given an opportunity to admit the violation or contest the charges.

- Mayor asked about new owner at Spickard Agency if they had come in for business license, they have.
- Mayor asked about the Tree Lighting in December, Santa is available on December 2nd, everyone agreed with that date.
- Mayor reported that Jeff Little had come to her with an agreement from January 1987, where he had an agreement with the City of Waleska (not signed by anyone from Waleska) that he was making payments for a meter in case water was ever run down his road (which is not mentioned on the agreement). The price of the agreement in 1987 was \$975.00, he has only paid \$40.00. Council agreed that they could not honor this agreement due to the payments were not made as agreed upon.

Councilmember Taylor asked if anything could be done about speeders on Bartow St. City Manager said that she would call Lt. McCloud and ask that a deputy sit in the afternoons when they are available to monitor this.
