Item 1:

Item 3:

Consideration to Approve April 9, 2018 Minutes Item 4:

Mayor Jones asked for a motion to approve the April 9, 2018 minutes. A motion to approve was made by Councilmember Mary Helen Lamb, and seconded by Councilmember Endicott, and approved by all members present.

Item 5:

**Consideration to Approve Budget Amendment** 

Mayor Jones asked for a motion to approve a Budget Amendment to move Capital Outlay Water for Pleasant Arbor from Water Fund to SPLOST Fund. A motion to approve was made by Councilmember Mary Helen Lamb and seconded by Councilmember Costales, and approved by all members present.

## Item 6: Consideration to Award Yard of the Month

Mayor Jones asked for a motion to award Yard of the Month. A motion was made by Councilmember Mary Helen Lamb to award May Yard of the Month to Dennis "Hill" Cochran, seconded by Councilmember Endicott, and approved by all members present.

#### Item 7: Water System Report

Jason Townsend of Townsend Pipeline reported that Pleasant Arbor will be starting as soon as they finish up another project. Jason asked Lamar Rogers how the Highway 140 project was coming, and Mr. Rogers reported that he is figuring that the estimated cost will be approximately \$210,000 for the City of Waleska. Mr. Rogers also reported that the crosswalk at City Hall that was previously approved by DOT has now been denied. DOT came out to look with Mr. Rogers and the way it would have to be done is not feasible. Mayor Jones asked for a motion to abandon the crosswalk project. A motion was made by Councilmember Mary Helen Lamb, seconded by Councilmember Jon Costales, and approved by all members present.

## Item 8: City Managers Report

City Clerk Robyn Smith gave Mayor and Council their budget binder for review.

Robyn Smith also asked Mayor and Council to approve the costs to customers for

Sanitation Services through Waste Management. After lengthy discussion, Mayor Jones asked for a motion to charge each customer \$20 a month for the new sanitation service. A motion was made by Councilmember Lee Lamb, seconded by

Councilmember Ice, and approved by all members present.

Robyn Smith also asked Mayor and Council to approve the cost to customers for a second bin. Mayor Jones asked for a motion to charge any customer that wants a second bin \$25 a month. A motion was made by Councilmember Mary Helen lamb, seconded by Councilmember Lee Lamb, and approved by all members present.

Robyn Smith also asked Mayor and Council to approve the cost to customers for house pickup for those who are not disabled or seniors. Mayor Jones asked for a motion to charge each customer wanting house pickup who isn't disabled or a senior \$25 a month for this service.
