- S Hwy 140 meter changed out except Mr. Moss
- They will be tying in Hickory Nut and McPhearson
- UWS is at the chevron, and they will start putting in meters
- Darby and Land Rd are tied in
- They checked a series of valves at ballfield and the pressure increased from before
- Bridle Ridge called and he's at the point of needing meters. We have told him and emailed numerous times about this. He has a plumbing contractor that has called and asked him how to do it then doesn't have a clue how to do it. I told him he shouldn't have any body working on the water system that isn't certified contractor not a plumber. Whoever he gets Townsend Pipeline must check it.
- 177 acres that back up to laurel canyon. David Hatiban has called and wants City of Waleska to relinquish 2 parcels on Sam Nelson/Talcmine Ln. Council is all in agreement that we will not relinquish those parcels.
- Discussion was made on buying more water from CCWSA. They will sell all we can buy.

- 7045 Reinhardt Coll Pkwy paid their taxes and informed us that she will be fixing up the property in the spring.
- Newly elected officials are having a virtual class on March 29-31 M, T, W Monday from 1-5, Tuesday and Wednesday 8:30-4:30
- Informed Council that she will be starting the budget and a decision needs to be made by next meeting on raises

- Easements the Cline and Church easements have been obtained. After much discussion, council decided to do a temporary easement to Mr. Meadows to see if he would sign that. A motion was made by Councilmember Lee Lamb, seconded by Councilmember Bosch, and approved by all members present. The original recorded easement agreements for the other parcels were delivered to City Manager on 2-8-21.
