Call to Order

Mayor Mary Helen Lamb, called the meeting to order with a quorum present.

Item 6: Tacie Jo Bracken to speak to Council

Ms. Bracken explained to council that we had finished bank statements through May 2022 and were very close to closing out the audit. Councilmember Cochran asked for our cash totals for each fund. She replied that as of May 31, 2022, General Fund is \$244,456.24, Water Fund is \$447,782.04, Sanitation Fund is at \$5,311.43, ARPA is at \$71,359.30, and SPLOST is at \$1,195,134.56.

She also stated that she had some firms that she thought would be good as our Auditor and gave council the schedule for that to be finished. She will be our external account and come to the office once a month.

Item 7: Five Minute Public Hearing

Mr. Conley at Canyon Ridge Subdivision spoke to council about lowering the price of irrigation meters, that we would have more people buying them. City Manager Robyn Smith explained that Canyon Ridge is the only customers that would be buying irrigation meters because we are septic only in Waleska. He stated that City of Canton charged \$600 for an irrigation meter. Council told Mr. Conley we would look into this.

Item 8: Consideration to Approve IGA for SPLOST 2024

Mayor Mary Helen Lamb asked for a motion to IGA for SPLOST 2024.. A motion was made by Councilmember Bosch, seconded by Councilmember Lee Lamb and approved by all members present.

Item 10: Water System Report

Mayor Lamb reported that she had received an email from Nathan Brandon about Geneva Rd. Due to Mr. Townsend being absent this was tabled to get more information from him.

Item 11: City Manager Report

- City Manager asked again about the decision to implement a procedure where employees could receive a bonus at their 5/10/15/20 etc. anniversary. Councilmember Cochran made a motion to do a bonus in \$50 increments and revisit in 2 years, seconded by Councilmember Lee Lamb, and approved all members present.
- City Manager mentioned again about buying the lines at Ammons Rd.
 Councilmember Bosch suggested to go ahead, but attorney John Meier suggested that we wait for Mr. Townsend to see what else is involved.

Item 12: City Attorney's Report

 Asked about code ordinances, City Manager reported she had sent the email, but had not heard back from Municode.

Item 13: Mayor's Report

 Mayor Lamb mentioned that the food truck is now stationed at the church at the 4-way and highly recommended everyone to check them out.

Item 14: Council Remarks

 Councilmember Lee Lamb asked if 423 Bartow St. had been rezoned backed to residential. Everyone on council said that it had been, City Manager Robyn Smith said she would find out for sure.
