Mr. Townsend replied that it would cost money to do it now, and then turn around again in a month to dig there for the other leaks. Councilmember Cochran mention that if her water bill was to start going up, we can credit her. When we do this repair, we will abandon the old line. City of Waleska received quotes from Townsend Pipeline of \$137,035.00, and Turnipseed Engineers for \$28,500.00. We will need DOT and EPD permits to start the project and Mr. Rogers from Turnipseed Engineers will be doing that for the City of Waleska.

Mayor Lamb asked Mr. Townsend about George Gray Ln, and he hasn't spoken with Mr. Lewallen yet.

Mayor Lamb reported that we changed out the meter for Heritage Baptist Church because the first one we changed out was bad. It was reported that Bartow Paving was stealing water from the meter. Because the 1st meter was bad we couldn't tell how much water was used. Jason Townsend told City Manager Robyn Smith that you can't steal water from the meter.

City Manager Robyn Smith reported that the budget for 2020-21 will be reviewed at next council meeting.

Item 6: City Attorneys Report
